##### Health Department

Commissioner Stevens moved, Plager seconded, to *authorize the Chairman to sign the Grant between Adams County Health Department and the State of Washington Department of Ecology No. G0600358 for the period January 1, 2006 through December 31, 2007 providing for maximum eligible costs of \$132,972 to review ground water monitoring data, permitting and inspection of solid waste handling facilities including biosolids complaint, inspections and technical assistance.* **Motion carried.**

### Community Counseling
