**ORDER OF BOARD OF COUNTY COMMISSIONERS

**IN THE MATTER OF CREATING POSITION NO. 1008 – VICTIM WITNESS
COORDINATOR**

WHEREAS, grant funding was made available from the State of Washington Office of Crime Victims Advocacy, Community Services Division to support Victim/Witness Assistance program activities; and,

WHEREAS, the need for this position was presented to the Legislative Body of the County during the 2010 budget preparation process; and,

WHEREAS, there was concurrence that there was sufficient need within the county to justify the creation of the position;

THEREFORE BE IT HEREBY RESOLVED that Position No. 1008 – Victim Witness Coordinator is hereby adopted; and,
