Commissioner Marshall moved, Hartwig seconded, to *authorize the Chairman to sign Agreement E17-028, Amendment A, between Adams County and Washington State Military Department and Energy Facility Site Evaluation Council.* **Motion carried.** (Budget sheet has been revised; contract amount of \$27,250 remains unchanged; expiration date of June 30, 2017 remains unchanged.)

Commissioner Marshall moved, Hartwig seconded, to *authorize the Chairman to sign Agreement E18-001 between Adams County and Washington State Military Department and Energy Facility Site Evaluation Council in the amount of \$29,164, for the period July 1, 2017 through June 30, 2018 plus additional related documents – Debarment Form; W-9; and, Signature Authorization Form (full Board).* **Motion carried.** (To provide EFSEC pass-through dollars (SFY2018) for the county to conduct radiological emergency

preparedness program related duties relating to the Columbia Generating Station nuclear power plant.)

- law and justice costs
- counseling or health services for non-assisted populations
- a lack of facilities for observation or commitment of mental health patients
- a lack of redundancy in fiber line in Adams County, hindering emergency services as well as business growth
