RESOLUTION NO. R-024-2019

**ORDER OF BOARD OF COUNTY COMMISSIONERS
ADAMS COUNTY, WASHINGTON**

**IN THE MATTER OF ESTABLISHING FUND #130A SEIZED PROPERTY
LITIGATION RESERVE**

WHEREAS, the Adams County Sheriff, on occasion conducts drug related investigations which may result in the civil seizure of real and personal property as well as currency; and
WHEREAS, upon completion of the forfeiture process the Adams County Sheriff notifies the Adams County Treasurer of funds which have been forfeited to the agency or are the product of

sales of property which has been sold by the agency. The Adams County Treasurer properly disburses funds to the State of Washington pursuant to RCW 69.50.505 and places retained funds in appropriate designated county accounts; and;

WHEREAS, the seizure and forfeiture process can result in significant expense to the County, including without limitation prosecution services, clean-up costs, accounting, and law enforcement overtime; and

WHEREAS, RCW 69.50.505 also provides a means by which claimants and respondents may contest the seizure/forfeiture of funds and property, and in the event such a claim is adjudicated by a court of competent jurisdiction as improper, such claimant/respondent may be entitled to an award of attorney fees and costs; and

WHEREAS, the County wishes to establish a reserve fund in which a portion of funds derived from the forfeiture process will constitute a litigation and operation reserve. Fifty percent (50%) of all funds derived from the forfeiture process shall be deposited by the Adams County Treasurer in such reserve fund on a quarterly basis until such fund reaches a balance of One hundred thousand dollars (\$100,000); and

THEREFORE, BE IT HEREBY RESOLVED that fund 130A Forfeited Property Litigation and Operation Reserve be established, and all funds set aside therein shall be reserved to compensate for expenses as set forth above, and as approached by the Adams County Board of Commissioners.

BE IT FURTHER RESOLVED that the Adams County Treasurer shall make appropriate deposits as set forth in the text of this resolution.
