Budget Workshop – District Court Position 2

Judge Benzel, along with Probation Officer/Manager Martinez, reviewed Fund #001/016. Noted in the budget were increased costs for juror and witness fees; a minor increase for interpreter fees; and, minor increases in travel/training and law books. Two (2) high volume scanners in the amount of \$5,000 and three (3) head sets in the amount of \$1,000 were identified as capital expense items. Additionally, Fund #001/017 was reviewed with Judge Benzel requesting Mr. Martinez be placed at EE1, Step 4 of the Adams County Exempt Employee Salary Schedule. A capital expense purchase of \$1,000 for a desk was identified.

Emergency Management

Hazard Mitigation Grant *(This contract was originally signed on September 25, 2019 during regular session. The state omitted a contract number on that document and requested the county execute another agreement with the contract number affixed.)*

Commissioner Hartwig moved, Thompson seconded, to *authorize the Chairman to sign Hazard Mitigation Grant Program Contract #D20-004 between Washington State Military Department, FEMA, and Adams County in the amount of \$70,000 (\$52,500 FEMA portion; \$8,750 State Portion; \$8,750 County portion) for the period August 8, 2019 through April*

21, 2021, plus additional related documents – Debarment Form; and, Signature Authorization Form (full Board). **Motion carried.**

Homeland Security Grant

Commissioner Hartwig moved, Thompson seconded, to *authorize the Chairman to sign Agreement E20-105 Homeland Security Grant between Washington State Military Department and Adams County in the amount of \$18,000 for the period June 1, 2019 through August 31, 2020 (Emergency Management Performance Grant (EMPG) to assist in preparing for all hazards through sustainment and enhancement); plus additional related documents – Debarment Form; W-9; and, Signature Authorization Form (full Board).*
