Sheriff's Office

Undersheriff Hunt came before the board to ask if the Sheriff's office could fill a deputy position in Othello when Deputy Jason Erickson leaves to take a job with Benton County. Erickson's last day will be January 28th. If that position can be filled it will be offered to anyone in District one who would like to move to Othello. Undersheriff Hunt is pretty sure no one in District One will want to move to Othello so in that case Craig Frank will be offered the job. Craig is currently working in the jail and is the number one person on the Deputy's list. That will then leave a corrections position open which will need to be filled. The Sheriff's office could advertise or hire off the current Deputy's list. The board by **consensus authorized filling the deputy position vacancy; and, filling the resultant vacant corrections position if Corrections Officer Craig Frank transfers to the vacant deputy position.**

Caring Neighbors gave the Sheriff's Office \$1,022 to purchase a GPS tracking unit that you pop on vehicles and you track it on the internet. The money received is enough to purchase the unit, activate it, and receive one year of maintenance service. In the past the Adams County Sheriff's office has had success using borrowed tracking devices during investigations. The board by **consensus authorized the purchase of the GPS tracking unit utilizing Caring Neighbors funds.**

The Sheriff's Office would also like to replace an older tazor and keep it only as a back up. Trade in value is around \$35. A new one will cost approximately \$800. Board **consensus authorized the purchase of a new tazor.**
