Barbara Anderson presented for approval a six-month extension contract for the period July 1, 2011 through December 31, 2011 for the Emergency Shelter and Homelessness Prevention Program (ESHP) reflecting an amount of \$15,900 for the period. Discussion followed on the continued funding status of the Network. Barbara Anderson spoke regarding future Department of Commerce funding and the new requirement for local matching funds noting that the Family Policy Council would no longer exist under the new structure. Commerce is expected to issue RFP's for the Consolidated Housing Grant program that will then follow the county's fiscal year (January 1 through December 31). The approved applicant would be the grant recipient and then could choose to subcontract the services with another agency. **Board consensus chose to discuss the Network status and the disposition of any future grant applications, as well as the administration of them, during a meeting when the full Board was seated before making any decisions.**

**ORDER OF BOARD OF COUNTY COMMISSIONERS
ADAMS COUNTY, WASHINGTON**

**IN THE MATTER OF DETERMINING THE LOCATION FOR THE SALE OF PROPERTY
TO SATISFY DELINQUENT REAL PROPERTY TAXES**

WHEREAS, on the 19th day of May, 2011, in Adams County Superior Court, Cause 10-2-00183-6 Decree and Order of Sale was entered directing Adams County to sell certain real property to satisfy liens for delinquent taxes; and,

WHEREAS, it is proper under the provisions of RCW 84.64.080 for the undersigned Board of County Commissioners to determine the time, between 9:00 a.m. and 9:00 p.m., date, and the location where the sale will be conducted; and,

WHEREAS, it appears to said Board that a suitable place to conduct said sale is outside the Treasurer's Office on the second floor of the Adams County Courthouse located at 210 W. Broadway, Ritzville, Washington; and,

WHEREAS, it appears that a suitable time for the sale is 9:00 a.m. on Friday, June 24, 2011;

THEREFORE BE IT HEREBY RESOLVED that the sale of certain real property to foreclose the tax lien for delinquent real property taxes, which are the subject of Adams County Tax Cause No. 10-2-00183-6, be held outside the Treasurer's Office on the second floor of the Adams County Courthouse, 210 W. Broadway, Ritzville, Washington, at 9:00 a.m. on Friday, June 24, 2010.
