Public Works

Director O'Brien reported on general road maintenance and road conditions following large volumes of rain. Danekas Rd was reported to have water and six to eight inches of mud and straw over the roadway due to culverts being plugged with debris. A 1500 ft. section of the shoulder was affected and will need to be repaired.

Adams County Fairgrounds

The Adams County Fairgrounds was vandalized when someone kicked in the door of the horse department office. Nothing appeared to be missing. The Board discussed the possibility of installing security cameras in different areas of the fairgrounds.

With the receipt of the preliminary materials list for the electrical project at the fairgrounds and with the drawings anticipated by the end of the week, work is expected to begin by August 1, 2012.

The State Fairboard rates the grounds on the ease of directions for attendees so additional signs will be made to facilitate this request from the Fair Association. Facilities Manager Sackmann has been notified of this as well as other items (baby changing stations in the restrooms, locks on doors, etc.) recommended by the Association to insure an excellent State rating. Director O'Brian has been in contact with Brent Stenson of the Adams County Health Dept about general improvements to the RV line including regulations and requirements for installation of a sewer system and holding tanks v. drain field. Additional research will be done on this proposal.

Bruce Transfer Station

On Friday July 13 a "hot spot" in a steel trailer containing garbage bags, cardboard, and paper at the Bruce transfer station ignited. The back of the trailer was burned but is salvageable. A portion of the unburned debris was transferred to another trailer which later ignited Saturday. By Sunday a third trailer ignited and after it was put out an employee remained on site overnight and into Monday. The Washington Counties Risk Pool will be notified and an adjustor will be called so appropriate claims can be made.

Lind-Hatton Road Project #4, CRP-159

Commissioner Stevens moved, Hartwig seconded, to authorize the Chairman to sign the Easement from Dorothy L. Doyl, etal to Adams County for a portion of Section 30, Township 17 North, Range 33 E.W.M. for the Lind-Hatton Road Project #4, CRP-159. Motion carried. 11:07:03 AM
