Adams County Health Department Strategic Plan

Callie Moore reviewed the Adams County Health Department Strategic Plan 2014 Year End Report and explained how the goals and objectives of the Plan were met. The Plan priorities were:

Protect the communities' health and prevent disease;
Identify and prioritize the communities' health needs; and
Promote Adams County Health Department through improved strategies.

Moore also presented the Strategic Plan for 2015-2017 with an explanation of how the Health Department will meet the goals and objectives of the Plan. Priorities were unchanged from the 2013-2014 Strategic Plan

Minor changes will be made to the Plan prior to Board approval.

Integrated Health Care Services

Commissioner Stevens moved, Hartwig seconded, to *authorize the Chairman to sign Contract #1463-28917, Amendment #1, between Adams County and DSHS Division of Behavioral Health and Recovery for an*

increase of \$2,500 for a total amount of \$17,500 effective December 15 2014 through September 30, 2015. (Change of contract terms and adding additional dollars). **Motion carried.**

Environmental Health

Guse presented a Department of Health temporary delineation of environmental health tasks for May and June, 2015. The Washington State Department of Health will temporarily assist the Adams County Health Department with food service inspections and pool inspections. DOH will require Adams County to contract with another agency for a plan review of facilities for new food establishments.
